## STATEMENT OF COMMITMENT

### FOR FSC® CHAIN OF CUSTODY FSC-C164909

GRUP GIRÓ Management has decided to implement a Chain of Custody Management System pursuant to the requirements of the FSC-STD-40-004 ES international standard for Chain of Custody Certification for products manufactured by the group.

The FSC® chain of custody system implemented describes all the management and production requirements to control the chain of custody, labelling and sale of FSC® certified products and involves the evaluation of forest products from the tree to the final product, including all processing, transformation, manufacturing and handling stages, therefore verifying that the materials of forest origin used come from sustainably managed forests.

GRUP GIRÓ declares that it is not directly or indirectly involved in the following activities:

- Illegal logging or trade in illegal timber or forest products;
- Infringement of traditional and human rights in forestry operations;
- Destruction of high conservation values in forestry operations;
- Significant conversion of forests into plantations or other uses;
- Introduction of genetically modified organisms in forestry operations;
- Infringement of any of the ILO Fundamental Conventions, as defined in the ILO Declaration on Workplace Fundamental Principles and Rights, 1998, specifically:
  - It does not prevent workers from freely associating, electing their representatives, or collectively bargaining with the company.
  - It does not use forced labour.
  - It does not hire workers below the legal minimum age of 15 years, or below the compulsory schooling age, if this is higher.
  - It does not impede equal opportunities and treatment for the organization's staff.
  - The working conditions do not endanger workers' health or safety.

GRUP GIRÓ also declares its commitment to its workers' occupational health and safety.
